# **SECTION 3: HAZARDS IDENTIFICATION**

# 3.1 EMERGENCY OVERVIEW

Odor, Color, Grade: Ester Solvent Odor Light Red

General Physical Form: Liquid

Immediate health, physical, and environmental hazards: Combustible liquid and vapor. Closed containers exposed to heat from fire may build pressure and explode. Vapors may travel long distances along the ground or floor to an ignition source and flash back. May cause chemical eye burns. May cause chemical skin burns. ### 3.2 POTENTIAL HEALTH EFFECTS

#### **Eve Contact:**

### **Skin Contact:**

Blood Effects: Signs/symptoms may include generalized weakness and fatigue, skin pallor, changes in blood clotting time, internal bleeding, and/or hemoglobinemia.

# 4.1 FIRST AID PROCEDURES

#### 7.1 HANDLING
