## Section 5. Fire-fighting measures

#### Specific hazards arising from the chemical

Flammable liquid and vapor. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. #### **Precautions for safe handling**

#### **Protective measures**
