

**Warranty – Professional Use  
Kansas Jack Branded Equipment**

The Snap-on company distributing the collision repair equipment (the “Equipment”) identified in this Owners manual (“Snap-on”) provides the following warranty to customers who purchased the Equipment from an authorized Snap-on Distribution channel for use in their profession (“Buyer”).

During the warranty period stated below, Snap-on warrants that the Equipment will be free from defects in workmanship and materials. The warranty period shall commence on the date the Equipment is delivered to the Buyer.

This warranty only extends to the original Buyer and cannot be transferred or assigned. During the applicable warranty period, at its option, Snap-on will repair or replace the Equipment which fails to give satisfactory service due to defective workmanship or materials, or provide a refund by repaying or crediting Buyer with an amount equal to the purchase price of the Equipment. Repair, replacement or refund shall be at the sole election and expense of Snap-on, and is Buyer’s exclusive remedy in place of all other rights and remedies. To obtain warranty service, contact a Snap-on representative or Snap-on at 1-800-582-5215. Proof of purchase must be provided with all warranty service requests.

Buyer shall be responsible for all freight charges for the return of Equipment covered under this warranty. Repaired or replaced equipment shall be returned to Buyer freight prepaid. In the event a chain is covered under this warranty, Buyer is required to return the entire chain to Snap-on including broken link. By repairing or replacing the Equipment, or providing a refund, Snap-on does not waive a claim that the Equipment nevertheless has been subject to abnormal use.

Snap-on does NOT provide any warranty for Equipment subjected to “Abnormal use”. “Abnormal use” includes misuse, accident, modification, alteration, unreasonable or improper use, abuse, corrosion, exposure to chemicals, non-standard installation, neglect, lack of maintenance, or use after the Equipment is significantly worn. Further, Snap-on does NOT provide a warranty for component parts not manufactured by Snap-on such as pumps and power winches, and those component parts shall be only subject to the manufacturer’s warranty.

**THE FOREGOING WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES NOT EXPRESSLY SET FORTH HEREIN, WHETHER EXPRESS OR IMPLIED BY OPERATION OF LAW OR OTHERWISE, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.**

**Snap-on and its affiliated companies shall not be liable for any incidental, special or consequential losses, costs or damages incurred by Buyer or others, directly or indirectly arising from the sale, handling or use of the Equipment, or from any other cause with respect to the Equipment or this warranty, whether such claim is based upon breach of contract, breach of warranty, strict liability in tort, negligence or any other legal theory (including without limitation, lost profits, revenues, anticipated sales, business opportunities, goodwill, or interruption of business or other injury or damage).**

To the extent allowed by applicable law, this warranty and all rights and obligations hereunder, including matters of construction, validity and performance, shall be governed by the substantive laws of the State of Wisconsin, without giving effect to the principles of conflicts of law thereof.
