A. EMERGENCY OVERVIEW:

Physical Appearance and Odor:

translucent paste-like solid, odorless.

Warning Statements:

This product, as sold, does not meet the regulatory definition of a hazardous material. This product contains dimethylpolysiloxane which can generate formaldehyde as a byproduct of oxidative thermal decomposition beginning at approximately 150 C (300 F). Exposure to formaldehyde can cause adverse effects such as skin and respiratory ensitization and eye and throat irritation. Formaldehyde is a potential cancer hazard, evaluate and control exposure .o formaldehyde when warranted by conditions of use.

B. POTENTIAL HEALTH EFFECTS:

Acute Eye:

Slightly irritating. May cause redness, irritation.

Acute Skin:

Non-irritating. Low acute dermal toxicity.

Acute Inhalation:

Inhalation not likely.

4. FIRST AID MEASURES

FIRST AID MEASURES FOR ACCIDENTAL:

Eye Exposure:
