## Delphi Engine Management: Limited Product Warranties

Delphi Powertrain Systems, LLC (“Delphi”) warrants to the original purchaser of the Engine Management products listed by product categories below as sold by Delphi (each a “Product” or collectively “Products”) to be free of defects in material and workmanship, for the warranty periods set forth below.

Control Valves:	Twelve (12) months from date of installation, or 12,000 miles (or 20,000 kilometers), whichever occurs first
Diesel Injectors:	Twelve (12) months from date of installation, with unlimited mileage during the 12-month period
EGR Valves:	Ninety (90) days from date of installation, or 3,000 miles (or 5,000 kilometers), whichever occurs first
Engine Sensors:	Twelve (12) months from date of installation, or 12,000 miles (or 20,000 kilometers), whichever occurs first. Engine sensor products include cam/crank, knock, MAF, MAP, oxygen, speed, temperature, and throttle position sensors
Fuel Injectors:	Twelve (12) months from date of installation, or 12,000 miles (or 20,000 kilometers), whichever occurs first
Ignition Coils:	Thirty-six (36) months from date of installation, or 36,000 miles (or 58,000 kilometers), whichever occurs first
Ignition Wire Sets:	Limited lifetime warranty
Ignition (all other):	Twelve (12) months from date of installation, or 12,000 miles (or 20,000 kilometers), whichever occurs first. Ignition products include assemblies (excluding Ignition Coils and Wire Sets) and any other components packaged with these ignition products as supplied by Delphi. These other components include, but are not limited to, gaskets, filters and other hardware necessary for the installation as packaged by Delphi.

Delphi will, as its sole obligation under this warranty and at its option, replace or repair any Product at its own cost that does not conform to these warranties within the applicable warranty period, subject to the exclusions set forth in this limited warranty. Repair or replacement during the warranty period shall not include any cost (including labor) to remove and install a Product or to restore a vehicle to its proper operating condition. Any repaired or replaced Product shall also remain subject to the original warranty period from the date of the original installation or mileage, whichever occurs first, and any repair or replacement shall not extend the original warranty period in any manner or start a new warranty period.

### Exclusions and Disclaimers of Warranties

- These warranties are the only express warranties made by Delphi for the Products.
- This limited warranty is not transferable and applies only to the original purchaser of the Product. A dated purchase receipt or other written proof that the Product is within the warranty period will be required in order to honor your warranty claim.
- Delphi will not be responsible for damage resulting from any (i) deviation from Delphi’s application recommendations as stated in or on Delphi’s online catalog system or any packaging, labels or instructions with a Product, (ii) installation of a Product in a manner which is inconsistent with Delphi’s written instructions or accepted industry standard, (iii) alteration or modification of a Product, (iv) misuse, (v) neglect, (vi) abuse, (vii) accident, or (viii) normal wear and tear, improper application, installation or operation of the Product.
- This warranty does not apply to any Product that is installed in vehicles used for towing exceeding the vehicle manufacturer’s defined limits, racing, public service, security or government use, off-highway recreational use, or four-wheel drive off-highway competition.
