## **Limited Lifetime Warranty**

We warrant all NAPA radiators sold only in the U.S. and any parts of those radiators furnished by NAPA to be free from defects in material or workmanship for as long as the first retail purchaser owns the vehicle in which the NAPA radiator was originally installed. Regular preventive maintenance, as recommended by the vehicle manufacturer, including the use of **DISTILLED WATER**, is required to maintain this lifetime limited warranty. This warranty does not apply to radiators that have failed from external corrosion, including salt air corrosion in coastal areas, during the first five years. SUBJECT TO WARRANTY STOPPERS AND STANDARD LIMITED WARRANTY TERMS, LIMITATIONS AND DISCLOSURES.

In the event the warranty claim is approved, the original purchaser shall be responsible only for the cost of labor, **DISTILLED WATER**, antifreeze and any additional parts required to complete the installation of a replacement radiator in the vehicle in which the radiator was originally installed.

This limited lifetime warranty does not apply to products that have been altered outside the factory in any way, in the judgment of NAPA, to negatively affect the performance and or function of the radiator. This warranty does not cover the effects of physical or chemical properties of water, steam or other liquids or gases used in the radiator. This warranty does not cover damage to connection threads stripped or damaged during installation. This warranty does not cover engine damage caused by overheating of the cooling system. We are not responsible for any damage due to operator negligence, including, but not limited to, the failure of the operator to monitor and comply with lights, gauges and/or other signs or signals warning of impending engine overheating. This warranty does not extend to radiator failure that results from the placement of the radiator in an incompatible or mechanically unsound vehicle. Please consult a NAPA Products Catalog for identification of compatible radiator models. We reserve the right to discontinue or obsolete any model of radiator without advance notice. If we discontinue or obsolete a model of radiator and it is no longer available, this warranty is null and void with respect to that model. We reserve the right to change or improve the design of any NAPA product without assuming any obligation to modify any product previously manufactured.

If the radiator fails due to a defect in material or workmanship, the original purchaser shall be responsible for presenting the defective radiator and a COPY of the ORIGINAL PURCHASE RECEIPT to a participating facility to verify the cause of the radiator failure. RETAIN YOUR ORIGINAL RECEIPT for future proof of purchase. All parts submitted for warranty must be returned freight prepaid in an original style of packaging, carefully packed for returns. All risks of loss or damage are retained by the customer while the goods are in the possession of the freight carrier in route to the participating facility. Repair or replacement of the radiator at our sole discretion shall be the SOLE AND EXCLUSIVE REMEDY to which NAPA is obligated and to which the original retail purchaser is entitled.

NAPA SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND RESULTING FROM THE ORDER OR USE OF ITS PRODUCTS.
