

# MSA Accountability System Software Installation Instructions



*The instructions below will enable you to download the latest version of the MSA Accountability System or update your current software for the following operating system: Windows XP Service Pack 3, Windows 7 32 bit, Windows 8 32 bit.*

1. Go to MSA's website, <http://us.msasafety.com/productSoftwareDownloads> to view MSA's Software Downloads page that includes MSA Accountability System software.

**IMPORTANT: Users of this software must be administrator users who are registered with the PC.  
If you are not an administrator, please contact your PC administrator.**

2. Right click on MSA Accountability System, choose **Save (create file)**.
3. Locate the file you just saved and double-click.
4. On the WinZip Extractor screen, click **Setup**.
5. Click **Next** on the Install Wizard screen.
6. Read the license agreement, click **Accept** and click **Next**.
7. On the Setup screen, choose **New** to install for the first time or **Update Installation** to replace current installation version and retain incident files.
8. Select destination folder and click **Next**.
9. Click **Install** to begin the installation process.
10. When installation is complete, click **Finish**, then see Accountability System user manual for operating instructions.

1. Go to MSA's website, <http://us.msasafety.com/productSoftwareDownloads> to view MSA's Software Downloads page that includes MSA Accountability System software.  
**IMPORTANT: Users of this software must be administrator users who are registered with the PC. If you are not an administrator, please contact your PC administrator.**
2. Right click on MSA Accountability System, choose **Save (create file)**.
3. Locate the file you just saved and double-click.
4. On the WinZip Extractor screen, click **Setup**.
5. Click **Next** on the Install Wizard screen.
6. Read the license agreement, click **Accept** and click **Next**.
7. On the Setup screen, choose **New** to install for the first time or **Update Installation** to replace current installation version and retain incident files.
8. Select destination folder and click **Next**.
9. Click **Install** to begin the installation process.
10. When installation is complete, click **Finish**, then see Accountability System user manual for operating instructions.

**Next, connect hardware via USB port. A warning should appear stating that the driver device was not successfully installed. If this warning appears, complete the following instructions:**

1. Go to your **Control Panel**, then **Control Panel Items**.
2. Click on **Administrative Tools**.
3. In Administrative Tools, click on **Computer Management**.
4. In Computer Management, under Other Devices, right-click on **Telemetry Transceiver Box**.
5. Click **Update Driver Software**.
6. In Driver Software, select **Browse my computer for driver software**.
7. Using the **Browse** button, select the location – **C:\Program Files(x86)\MSA\MSA Accountability System**.  
**Be sure to put a check mark in the Include Subfolders Box before continuing.**
8. Click **Next**.
9. A screen should appear confirming successful update of the driver software. Close this screen. Installation is complete.
