- 1)The design and construction of the equipment shall be strictly in accordance with description, condition and drawings as mentioned in the SIRA Certification Test Reports referred to above.
- 2)The equipment shall be used only with approved type of accessories and associated apparatus.
- 3)Each equipment shall be marked either by raised lettering cast integrally or by plate attached permanently to the main structure to indicate conspicuously:-

1. The gas detector shall not be taken inside the vessels/tanks.
2. The Gas detector suction tube pipe Length 15m shall be provided .
3. The detector shall be operated from safety distances mentioned under Petroleum Rules,2002.
