This Approval is granted subject to observance of the following conditions:-

- 1)The design and construction of the equipment shall be strictly in accordance with description, condition and drawings as mentioned in the FTZU Test Reports referred to above.
- 2)The equipment shall be used only with approved type of accessories and associated apparatus.
- 3)Each equipment shall be marked either by raised lettering cast integrally or by plate attached permanently to the main structure to indicate conspicuously:-
  - (a) Name of the manufacturer
  - (b) Name and number by which the equipment is identified.
  - (c) Number & date of the test report of the FTZU applicable to the equipment.

## Conditions of the Approval:-

1. The gas detector shall not be taken inside the vessels/tanks.

2. The Gas detector suction tube pipe Length 15m shall be provided.

3. The detector shall be opertated from safety disatances mentioned under Petroleum Rules, 2002.
