15 **Description of Product**

The equipment is a hand-held lighting torch, for use in Zone 0, temperature class T4, Gas group IIC environments. The protection concepts applied are intrinsic safety Ex ia and op is. It is battery powered equipment powered by three series connected primary 1.5 V AA cells or three secondary NiMH-AA 1.3 V cells. All housed within a non-metallic enclosure.

Within the enclosure, an electronic PCB and switch are used to control the light output of the LED.

The MSA XPS and 3325Z0 have the same shape, with the exception of a helmet mount pin on the MSA XPS model.


