**SRC (\*) = Slip resistance** – meets the following requirement:

- <u>surface</u>: ceramic / <u>lubricant</u>: <u>detergent</u> solution;
- surface: steel / lubricant: glycerol.

(\*) the final level of the anti-slip features is achieved after the first hours of trial stage.

### Additional requirements (Tab. 18 and 20 of EN ISO 2034<mark>5:2011):</mark>

**S1** = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil; **P** = penetration resistance of the sole; **HRO** = resistance to hot contact of the outsole; **HI** = heat insulation of sole complex.

Note: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

Marking:

on a stitched label and displaying the following information:

- CE Marking;
- Name/Trademark (printed also on the lateral side of the footwear) and complete address of the Manufacturer;
- designation of the footwear (= alphanumeric code: unique/unambiguous);
- nr. and year of the Standard of reference + safety symbols;
- size of the footwear;
- production date (month + year);
- additional information: internal codes.
