upper: black leather DAKAR Trekking CE declared thickness 2,0/2,2 (cod. DAC/NER) with inserts made of black fabric TECNIC in the quarter/collar area (cod. TLP/1081) and inserts made of black diamond water-resistant leather declared thickness 1,8/2,0 mm on both the tip and heel area (cod. DII/NER);
collar: black water-resistant leather (cod. PID/NER);
tongue: same leather as that of the upper, centrally lined and padded and same leather as that of the collar in the upper area;
bellows: black coated fabric ANDREA SILVIA (cod. ANS/NER);
vamp lining: black non-woven material AITELLE coupled with MTP4 D40 and black knit CHARMEUSE (cod. FCA/NEC);
rear lining: black three-dimensional fabric article AT 488 SPECIAL (cod. A8S/NER);
heel-grip: black microfiber article MICROLIM 0,8 SCAMOSCINA (cod. MI8/NER);
collar and upper tongue lining: black leather (cod. PEL/NER);
insole: white multi-layered fabric ZP03/1500 (cod. LC/ZP03) with a green stamp covered by the lining, which also serves as penetration-resistant insert;
removable insock: thermo-formed, made of black agglomerated material with a reinforcement made of anthracite grey foam material from the forepart area to the heel zone, coupled with black/silver fabric in contact with the foot (cod. FM126NA);
toe-cap: glass fiber article 604 CONTENDER (cod. 604FV).

Functions and performance levels:

basic requirements for safety footwear (see Table 2 and 3 of EN ISO 20345:2011):

all mandatory ones, among which:

SRC = Slip resistance – meets the following requirement:

- surface: ceramic / lubricant: detergent solution;
- surface: steel / lubricant: glycerol.

Additional requirements (Tab. 18 and 20 of EN ISO 20345:2011):

S3 = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil, water penetration resistance and absorption (water-repellent upper), penetration resistance, cleated outsole; **HRO** = resistance to hot contact of the outsole; **HI** = heat insulation of sole complex.

NOTE: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

Marking:

on a stitched label and displaying the following information:

- **CE Marking**;
- Name/Trademark and complete address of the Manufacturer;
- designation of the footwear (= alphanumeric code: unique/unambiguous);
- nr. and year of the Technical Harmonized Standard of reference + safety symbols;
- size of the footwear (also printed on the outsole);
- production date (month + year);
- additional information: internal codes.



NOTE: the Technical File contains a more detailed description of the PPE (material, method of assembly, photographs or drawings), performance data, safety functions and level of protection, elements of conformity to the basic and supplementary requirements. The Technical File is integral part of the present Certification, which has to be kept available by the applicant to be forwarded - upon request - to the entitled person (supervising body, Controlling Officer).
