rear lining: black three-dimensional fabric AT488 SPECIAL (code A8S/NER);

tongue: made of the same fabric as that of the collar, padded and lined;

bellow: black coated fabric ANDREA SILVIA (code ANS/NER), lined;

heel-grip lining: black microfiber MICROLIM 0,8 SCAMOSCINA (code MI8/NER);

insole: white multilayered fabric ZP03/1500 (code LC/ZP03) with green stamp, which

serves also as penetration-resistant insert;

removable insock: thermo-formed, in black agglomerated material with a reinforcement made of anthracite grey foam material from the forepart area to the heel zone, coupled with black/silver fabric in contact with the foot (code FM126NA);

toe-cap: glass fiber article 604 CONTENDER (code 604FV).

basic requirements for safety footwear (see Table 2 and 3 of EN ISO 20345:2011): all mandatory ones, among which:

SRC = Slip resistance – meets the following requirement:

- <u>surface</u>: ceramic / <u>lubricant</u>: detergent solution;
- <u>surface</u>: steel / <u>lubricant</u>: glycerol.

Additional requirements (Tab. 18 and 20 of EN ISO 20345:2011):

S3 = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil, water penetration resistance and absorption (water-repellent upper), penetration resistance, cleated outsole; **HRO =** resistance to hot contact of the outsole; **HI =** heat insulation of sole complex.

Note: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

Marking:

on a stitched label and displaying the following information:

- CE Marking;
- Name/Trademark and complete address of the Manufacturer;
- designation of the footwear (= alphanumeric code: unique/unambiguous);
- nr. and year of the Standard of reference + safety symbols;
- size of the footwear (printed also on the outsole);
- production date (month + year);
- additional information: internal codes.
