



COMMERCIAL VEHICLE GROUP (CVG) MILLION MILE LIMITED WARRANTY FOR NATIONAL SEATING SEATS

Commercial Vehicle Group (CVG) warrants that each new National Seating seat and all National Seating accessories and equipment (except upholstery covering and cushioning materials) supplied by CVG is free from breakage or excessive wear (to be determined exclusively by CVG) due to defect in material or workmanship for a period of the first one million (1,000,000) miles or seven (7) years of operation, whichever comes first, to the original purchaser.

CVG will replace from its factory, or at its option, repair any parts which, in the opinion of the manufacturer have failed or worn as stated previously. Warranty coverage for upholstery (foam and covers) is limited to one (1) year or one hundred thousand (100,000) miles. Warranty coverage on all components of the seat is limited to the replacement of the defective seat component. Further, during the first (1) year or one hundred thousand (100,000) miles, whichever occurs first, the manufacturer will reimburse the purchaser for costs incurred in the removal and replacement of defective parts, based on the number of man hours designated by the manufacturer to be required for such work at the base rate for mechanical labor prevailing in the purchaser's garage at the time of such repairs.

THIS WARRANTY SHALL BE CONSIDERED VOID IF, IN THE OPINION OF CVG, ONE OR MORE OF THE FOLLOWING CONDITIONS ARE PRESENT:

- (1) THE SEAT OR ANY ACCESSORY/EQUIPMENT HAS BEEN ALTERED, MODIFIED, CHANGED OR REWORKED IN A MANNER NOT PREVIOUSLY AUTHORIZED BY CVG.
- (2) THE SEAT HAS BEEN SUBJECT TO ABUSE, NEGLIGENCE OR ACCIDENT.
- (3) THE SEAT IS INSTALLED IN A MANNER THAT WOULD SUBJECT THE SEAT TO ABNORMAL USE.
- (4) WARRANTY DOES NOT APPLY TO BROKEN AIR VALVE STEMS OR AIR SYSTEM COMPONENT LEAKAGE DUE TO FOREIGN PARTICLES LODGED WITHIN, OR TO AN AIR SUPPLY CONTAMINATED WITH OIL OR WATER. ALSO NOT COVERED ARE AIR SPRINGS WITH CUTS OR PUNCTURES DUE TO NEGLIGENCE OR IMPROPER INFLATION.
- (5) NON-GENUINE REPLACEMENT PARTS HAVE BEEN SUBSTITUTED IN SUCH A WAY AS TO AFFECT THE SERVICEABILITY OF THE SEAT OR ANY PART THEREOF.

CVG MAKES NO OTHER EXPRESS WARRANTY AND OFFERS NO REMEDY EXCEPT AS HEREIN DESCRIBED. CVG DISCLAIMS ANY LIABILITIES FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM BREACH OF ANY EXPRESS OR IMPLIED WARRANTY WITH RESPECT TO THE NATIONAL SEATING PRODUCT COVERED BY THIS WARRANTY. ALL OTHER WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, INCLUDING IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND OF MERCHANTABILITY ARE LIMITED TO THE PERIOD OF THIS WARRANTY.

SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

FAILURE TO GIVE PROMPT WRITTEN NOTICE WITHIN THIRTY (30) DAYS OF THE DISCOVERY OF ANY DEFECT IN MATERIAL OR WORKMANSHIP WHICH OCCURS WITHIN THE WARRANTY PERIOD WILL VOID THIS WARRANTY. SEND SUCH NOTIFICATION TO:
