## HEATED GEAR - ONE YEAR WARRANTY

Every MILWAUKEE Heated Jacket/Hoodie is warranted to the original purchaser only to be free from defects in material and workmanship for a period of one year. Subject to certain exceptions, MILWAUKEE will issue credit or replacement for any Heated Jacket which, after examination, is determined by MILWAUKEE to be defective in material or workmanship for one year from the date of purchase. The MILWAUKEE Heated Jacket must be sent in to one of our Factory Service Branches for inspection, freight prepaid and insured. A copy of the proof of purchase must be included with the return. This warranty does not apply to damage that MILWAUKEE determines to be from misuse, alterations, abuse, normal wear and tear, lack of maintenance or accidents. Warranty Registration is not necessary to obtain the applicable warranty on a MILWAUKEE heated jacket/hoodie. The manufacturing date of the product will be used to determine the warranty period if no proof of purchase is provided at the time warranty service is requested.

Acceptance of the exclusive repair and replacement remedies described herein is a condition of the contract for the purchase of every milwaukee product. If you do not agree to this condition, you should not purchase the product. ## PROCEDURE

- Jackets are to be returned as a repair to the nearest Factory Service Centre.
- Freight to the FSC to be paid by the user.
- A copy of the proof of purchase must be included with the request, along with a brief description of the defect.
- The jacket will be inspected by a Milwaukee Service Technician.
- Product deemed to be defective will be replaced with a new jacket.
- Product determined to not be defective will be returned to the user, warranty refused.

# ACCESSORY, HAND TOOL AND SERVICE PARTS

## ACCESSORIES/HAND TOOLS/SERVICE PARTS - LIMITED LIFETIME WARRANTY

Every MILWAUKEE accessory, hand tool and service part is warranted to the original purchaser only to be free from defects in material and workmanship. Subject to certain exceptions, MILWAUKEE will issue credit for any accessory, hand tool or service part which, after examination, is determined by MILWAUKEE to be defective in material or workmanship for the lifetime of the product. A MILWAUKEE representative will inspect the defective item. A copy of the proof of purchase must be included with the credit request. This warranty does not apply to damage that MILWAUKEE determines to be from misuse, alterations, abuse, normal wear and tear, lack of maintenance or accidents.

## PROCEDURE

- Sales Representative must obtain proof of purchase.
- Should the issue be determined to be a manufacturer’s defect, the Sales Rep must contact Customer Service at [milwaukeecanadaorders@ttigroupna.com](mailto:milwaukeecanadaorders@ttigroupna.com) to ensure credit to the distributor.
- A copy of the proof of purchase must be included with the request, along with a brief description of the defect.
- The Sales Rep must take possession of the defective accessory, hand tool or service part and keep for a period of 3 months.
- Tracking will be done by product and territory to ensure there are no quality control issues.

# STILETTO

---

## STILETTO - ONE YEAR WARRENTY

Every Stiletto product is warranted to the original purchaser only to be free from defects in materials and workmanship for a period of one (1) year from the date of purchase, as shown by proof of purchase. During the warranty period, subject to certain exceptions, Stiletto will repair or replace with a new or reconditioned product, depending on availability, any product, which after examination, is determined by Stiletto to be defective in material or workmanship.

Thereafter, the remaining charges up to a total of 2000 or the remainder of the five (5) year period from the date of purchase, whichever first occurs, will be covered on a pro rata basis. This means that every customer gets an additional 1000 charges or three (3) years of pro rata warranty on the these battery packs, depending upon the amount of use. MILWAUKEE M18™ 48-11-1828 (with the serial number prefix “B41E” and later), V18™48-11-1830 (with the serial number prefix “E95”), and M28™ 48-11-2830 (with the serial number prefix “C71”) have different warranty periods, as listed.

Warranty Registration is not necessary to obtain the applicable warranty on a MILWAUKEE battery pack. The manufacturing date of the product will be used to determine the warranty period if no proof of purchase is provided at the time warranty service is requested.

Acceptance of the exclusive repair and replacement remedies described herein is a condition of the contract for the purchase of every milwaukee product.
