

## Agreement for Use of LifeWay Electronic File in Preparation of Resources for the Visually and Physically Impaired

THIS AGREEMENT is made and entered into on the date set forth below by and between Lifeway Christian Resources of the Southern Baptist convention, and name of church hereinafter called LICENSEE.

WHEREAS, the LICENSEE desires the right, privilege and authority to use the copyrighted work described below, and.

WHEREAS, Lifeway Christian Resources is willing to grant to LICENSEE a non-exclusive license to use the copyrighted work,

THEREFORE the parties agree as follows.

## 1. General Terms:

<u>Licensed Work:</u> An electronic file of product or a portion of product entitled:

(Title and ISBN of resource you are requesting)

The licensed work includes only the text portion of the product and does not include the right to use other materials included therein.

<u>Licensed Term:</u> three years

Authorized version(s): LICENSEE may only produce and distribute a Braille, big print, and/or audio version of the Work intended for use by those who are visually and physically impaired.

<u>Distribution Restriction</u>: Only for free distribution to members LICENSEE's church or to those attending or visiting the church for worship or study.

Other terms or restrictions: The electronic file of the Work may be used only for the purpose of producing versions for the visually or physically impaired and not for any other purposes. LICENSEE may not distribute the electronic file of the work in any manner or to any person, company, or church not listed in this document. LICENSEE shall not allow others to make a copy of the electronic file, borrow the electronic file, or to have possession of the electronic file.

- 2. Any products made from or derived from the electronic file shall contain the notice of copyright as it appears on the Work and shall add "Reproduced by permission of the copyright owner. Unauthorized duplication is prohibited."
- 3. If LICENSEE breaches this agreement, it may be terminated immediately by Lifeway Christian Resources.
- 4. At the expiration or termination of this agreement, LICENSEE shall destroy or return all copies of the electronic file to Lifeway Christian Resources and shall remove all copies from computers or other storage medium.
- 5. Neither this agreement nor any rights hereunder may be assigned by LICENSE.

6. This agreement shall be interpreted under the laws of the State of Tennessee, USA, without regard to the place of its physical execution. It is agreed that jurisdiction and venue shall be in the applicable State or Federal Court located in Davidson County, Tennessee, USA. The prevailing party in any court action shall be awarded costs including reasonable attorney fees.

IN WITNESS WHEREOF each party hereto has executed this license as of the day, month and year indicated below and the license becomes effective upon the date it is fully executed by both parties, however if this agreement is not fully executed within 30 days of the date of the first signature, this agreement is null and void.
