This limited warranty is valid only for units which have been maintained in accordance with instructions supplied with the newly purchased product. This limited warranty applies to end user purchases on or after July 19, 2023.

**How Long Does the Coverage Last?** The warranty lasts 5 years from the date of delivery to the original end user purchaser.

What Will Rubbermaid Do? If an item in the table set forth above provides to have a defect caused by material or manufacturing workmanship, Rubbermaid, at its sole election, replace the defective part or provide a replacement product or refund as provided herein. If Rubbermaid, in its sole discretion, determines that the product requires full replacement, then Rubbermaid will either replace the product or refund you the pro-rata portion of the purchase price of the product on a straight line depreciation basis of 20% per year. For example, if the product has been owned for 4 years, Rubbermaid will refund you 20% of the original purchase price.

What Does This Warranty Not Cover? The warranty applies only to products purchased and used by end users in the United States of America and Canada, and only to the original purchaser/owner and is not transferrable (except where prohibited by local law, which may include the Province of Quebec). All failures must be reported within the applicable limited warranty period. Any use of the product for purposes other than the storage of indoor waste will void this limited product warranty.

Commercial use or use other than for personal or household purposes is not covered by this warranty.
