


Anchorage Locations

Self-retracting devices are classified according to dynamic performance. For Class A devices, arrest distance must not exceed 24 inches; average arresting force must not exceed 1,350 lbs., or maximum peak of 1,800 lbs. For Class B devices, arrest distance must not exceed 54 inches; average arresting force must not exceed 900 lbs., or maximum peak of 1,800 lbs.
