

G1 Readiness Race

OFFICIAL RULES

CONTEST PERIOD: The G1 Readiness Race ("Contest"), hosted by MSA ("Sponsor") starts at 7:00pm Eastern Standard Time (EST) on Thursday, April 11, 2019 and ends at 10:00pm on Thursday, April 11 2019 ("Contest Period").

TO ENTER: During the Contest Period, entrants can submit one (1) entry per entrant by completing the G1 Readiness Race using MSA's equipment at the MSA Block Party. (www.msablockparty.com). Participation in the G1 Readiness Race will automatically enter entrants into the Contest. The two (2) Entrants who complete the race with the two (2) fastest times will be chosen as Finalists to compete head-to-head for final awards.

Prizes will be awarded at 10:00pm on Thursday, April 11, 2019.

ELIGIBILITY: The Contest is open only to those 21 years of age or older at the time of entry (Admittance to the MSA Block Party requires the entrant to be 21 years of age or older, therefore must be 21 to enter the Contest). WINNING ENTRIES: The Two (2) Entrants with the fastest times completing the Nine (9) steps of the G1 Readiness Race will be chosen as Finalists by MSA at the conclusion of the contest. In the event of a tie, a head-to-head tie breaker will be held. The two Entrants with the tied times will race against one another. The race times from the tie breaker will trump old times and will be used for final award placements.
