

# MSA's Globe Boots Contest

## OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER THE CONTEST.** PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

**GIVEAWAY PERIOD:** The MSA Globe Boots Contest ("Contest"), offered by MSA ("Sponsor") starts at 12:00 AM EST on August 1, 2022 and ends at 11:59 PM EST on August 30, 2022. ("Contest Period").

**HOW TO ENTER:** During the Contest Period, entrants can go to the contest landing page ([msafire.com/globe-boots-contest](https://msafire.com/globe-boots-contest)) and submit one (1) entry per entrant by completing the MSA Globe Boots Contest form found at the bottom of the landing page ([msafire.com/globe-boots-contest](https://msafire.com/globe-boots-contest)). Submission of this form will automatically enter the contestant in for the Contest. Incomplete/illegible entries are void.

Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.

All materials submitted become the property of the Sponsor and will not be returned or acknowledged. No communication regarding entries will be held.

By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to this Contest.

**ELIGIBILITY:** The Contest is open only to firefighters in the 50 United States and D.C., and Canada.

### **WINNING ENTRIES:**

Three (3) Potential Winners will be selected from Contest entrants at random and will receive one (1) pair of Globe boots each. Potential Winners may choose from structural firefighting, technical, EMS/wildland or station/wildland styles.

Potential Winners must claim the prize within 48 hours of being contacted ("Claim Period"). Failure to confirm contact with MSA within Claim Period will disqualify Potential Winner and an alternate can be selected. Upon disqualification, no further compensation will be given. The Sponsor can then choose one (1) new Potential Winner based off of the entrants submission, after which the Prize will remain un-awarded.

Acceptance of Prize constitutes permission to the Sponsor and its agents to use the winner's name and/or likenesses, prize information, photograph, voice, comments for purposes of marketing, advertising and trade without further notice, permission, compensation, or right of approval, unless prohibited by law.
