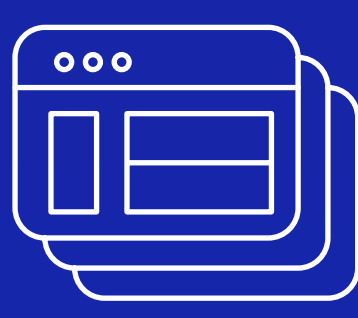

**Disparate systems** require auditors to use multiple programs and manual spreadsheets to validate coded patient claims.

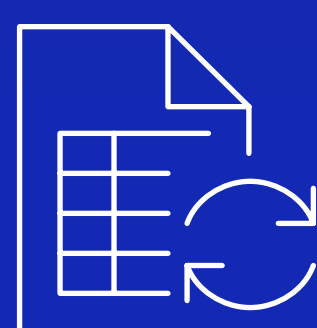


**The integrated platform and dashboard** help simplify validation and improve visibility.
