

- DO NOT install where water hammer conditions may occur. If water hammer conditions
  exist you must install a water hammer arrester. Contact a plumbing professional if you
  are uncertain how to check for this condition.
- The disposable filter cartridge MUST be replaced every twelve (12) months, at the rated capacity or sooner if a noticeable reduction in flow rate occurs.
