This usually involves providing preventive services, coordinating care and monitoring patient safety for at-risk groups. As a result of such efforts, health networks expect to reduce the rate of hospitalizations, emergency department (ED) visits, unnecessary tests, complications and related return visits to the hospital or ED.

However, none of this is possible without the right information. The foundation of effective population health is a deep understanding of how sick patients are and how they are being treated.

Solventum PPEs allow population views at a whole-person level of risk so comparisons are accurate and fair. Norm files are available for comparisons of benchmarks and can vary depending on payer type.
