## **Secure and Earn Incentive Terms and Conditions**

- 1. Reseller purchases require an eligible product from a Fortinet authorized distributor and the distributor provides an invoice to the reseller
- 2. This program only applies to qualified products included in the eligible SKU list (previous page)
- 3. Each FortiRewards claim must include at least 5 eligible SKUs, but can be across multiple opportunities
- Deal Registration is encouraged but not required, Deals without a DR or FTQ number will require more time to process
- 5. This program is available for new business only; renewals are not eligible
- 6. Partner billings with Fortinet must be \$15,000 or greater by the end of Q4'2024 to qualify for payout, regardless of FortiRewards payment preference
